Scenario Three	Action taken by families	Action taken by school
Child develops covid-19 symptoms at school.	Parents need to collect their child as soon as possible.	School will inform parents as soon as symptoms present.
	Parents should keep any siblings at home. Child with symptoms should isolate for 14 days from initial symptoms.	School will move the child away from the others. School staff may need to wear PPE while supporting the child.

The rest of the household should isolate for 14 days from day one of the child's initial symptoms.	School will not inform other families of any absence in the event of a negative test result.
UNLESSThe child has a covid-19 test and the test result comes back negative. This means siblings may return to school.Child with symptoms may return to school when they feel well enough.A covid-19 test can be booked here: book a test	School will have to communicate with parents if the test result is positive. Details will remain confidential. If the child is well enough but still in an isolating period, work will be set at the parents request for children to complete at home. Work will be set for siblings isolating alongside the child to complete.

		If the country was exempt on departure and added whilst abroad the absence will be recorded under Covid regulations and no fine will be issued
